Defective paint, such as peeling or chipping of factory clear coat or as determined by independent inspection; Damage caused by tree sap, water spotting or bird droppings.

**BUYERS LIFETIME WARRANTY:** Pro-Shield Appearance Protection System, Inc. hereby warrants a lifetime warranty to the original owner of the new vehicle having less than 5,000 miles, that should the fabric on its seats or carpeting professionally treated with Pro-Shield Fabric Protectant become stained as a result of ordinary water or oil based stains during normal use; Pro-Shield will remove the stained area and reapply Pro-Shield Fabric Protectant free of charge. If such professional cleaning is unsuccessful, Pro-Shield's only obligation will be to replace the stained fabric free of charge. To obtain service under this warranty, the vehicle must be brought upon the discovery of the affected area to an authorized Pro-Shield Dealer.

**EXCEPTIONS:** This warranty does not apply to the following: Damage caused by fire or any other natural casualties. Stains or damage caused by tar, gum, acid, bleach, paint, dyes, or other corrosive liquids or caustic substances;

Stains or discoloration caused by defects in the material resulting from flaws in the manufacture of the material or in its installation; Nor does it apply to vandalism, rips, tears, modification or alteration of treated surfaces. Regular cleaning and care is necessary to keep this warranty valid.
